The Iraqi Jordanian Company for Industry invites all specialized and qualified international companies in the fields of developing economic cities and/or industrial cities and/or development zones and/or free zones to participate in the above tender according to the following:

First: Conditions for participating in the tender:

Companies (Iraqi and/or Jordanian and/or any other nationality) with (allied/consortium and joint venture companies) are allowed to apply to participate in this tender, provided that the applicant for this tender processes the following documents-:

- 1. A document certifying that it is a legal entity duly registered/established under the laws of the bidder's country and has all required legal authority and power to and participate in such a bid.
- 2. A document proving that he has the financial ability to develop, implement, manage, operate, promote, market, maintain and sustain the economic city.
- 3. A document proving that he possesses the technical ability to develop, implement, manage, operate, promote, market, maintain and sustain the economic city.
- 4. He has valid and approved official documents for example, but not limited to (a commercial register that includes a description of the objectives, the implementation and development of economic cities, industrial cities, or development zones, and a permit / license for a similar business activities).
- 5. All these supporting documents shall be presented when applying for a copy of the tender documents.

Second: - Basic information and data

1. Employer: The Iraqi-Jordanian Company for Industry is a private limited liability joint stock company (Arab joint Company) established in 1981 and equally shared between the government of the Republic of Iraq and the government of the Hashemite Kingdom of Jordan. Its headquarters is in the Iraqi capital, Baghdad. The Company's objectives are to establish, finance and aquire industrial projects in the two countries and supervise managing or leasing other industrial projects.

2. The joint Iraqi-Jordanian economic city: - It has an area of (22) million square meters and is located on two parts of land, and as follows-:

- A. The first land part is situated on the territory of the Republic of Iraq and on the parcel of land numbered (3078/ Al-Rutba District 1) Treibil border crossing.
- B. The second land part is on the territory of the Hashemite Kingdom of Jordan and on the two parts No. (7 + 8) of the original land parcel Number (6) of Zone No. (1) Al-Karama Customs center from the lands of the village of Al-Karama Customs site.
- 3. Components and stages of implementation and development of the city-:
- A. The city is being implemented and developed in three phases (the first phase with an area of (10) million square meters, the second with an area of (6) million square meters, and the third is with an area of (6) million square meters too.
- B. The city includes the following proposed components:
- The industrial component: aims at creating developed land areas for investment in various industrial projects.
- The commercial component: aims at creating developed land areas for investment in various trade and commercial projects.
- Logistics component: It aims to provide developed land areas for investment in various storage projects.
- The financial, business, education and health component: aims at creating developed land areas for investment in projects providing financial services, professional and supportive business services, educational and health services.
- The residential and commercial component: It aims to provide developed land areas for investment in various residential and commercial service projects.
- The transportation component: it aims at creating developed land areas for airport, railway and transportation projects
- The administrative and services component: It aims to provide land spaces for the administration buildings necessary for the city's various administrative and service needs.
- Component of services and infrastructure: green areas, streets, sidewalks and services.

Third: - Description of the work required from the developer who will win the development tender.

Preparing studies, designs and engineering plans and drawings, developing, financing, implementing, managing, investing, promoting, operating, sustaining, and maintaining the proposed economic city and all its facilities, according to what is required in the tender documents, which include the following:
